

HEARING OFFICER ORDER

On September 12, 2013, the petitioner informed the hearing officer that it appears that language for one of the related permits has been resolved and will be used as a model for the remaining permit appeals. The petitioner stated that it will file an additional waiver of the statutory decision deadline to an including March 20, 2014.

IT IS SO ORDERED.




