

**HEARING OFFICER ORDER**

On June 12, 2014, all parties participated in a telephonic status conference with the hearing officer. The parties stated that they have continued discussions and meetings regarding language in various sections of a draft permit and report that they continue their steady progress. The parties anticipate that the permit will go to public notice in the near future. The permit will be a template for the other related Title V appeals before the Board. The petitioner stated that it will file an additional waiver of the statutory decision deadline to and including December 18, 2014.

The parties or their legal representatives are directed to participate in a telephonic status conference with the hearing officer on September 10, 2014 at 9:45 a.m. The telephonic status conference must be initiated by the petitioner, but each party is nonetheless responsible for its own appearance. At the status conference, the parties must be prepared to discuss the status of the above-captioned matter and their readiness for hearing.

IT IS SO ORDERED.




