NOTICE OF WAIVER OF 120-DAY DECISION DEADLINE

NOW COMES Petitioner, FLINT HILLS RESOURCES JOLIET, LLC (“Petitioner”), by and through its attorneys, HEPLERBROOM, LLC, pursuant to 35 Ill. Admin. Code § 101.308(c)(2), and hereby waives the statutory 120-day decision deadline for final action by the Illinois Pollution Control Board (“Board”) in this proceeding until September 15, 2016. In support of this Notice, Petitioner states as follows:

1. On July 21, 2015, Petitioner filed its Petition for Variance ("Petition") requesting a variance from the deadline for complying with the chloride standard at 35 Ill. Admin. Code § 302.407(g)(3) for its Channahon Facility pursuant to the terms and conditions outlined in its Petition.

2. On August 6, 2015, the Board accepted the Petition.

3. The current decision deadline for this matter is June 16, 2016.

4. Petitioner hereby voluntarily agrees to waive the statutory 120-day decision deadline until September 15, 2016.

WHEREFORE, Petitioner, FLINT HILLS RESOURCES JOLIET, LLC, prays that the Illinois Pollution Control Board accept this waiver of the statutory 120-day decision deadline for final action on Petitioner's Petition for Variance.
