
HEARING OFFICER ORDER

On February 18, 2016, all parties participated in a telephonic status conference with the hearing officer. The parties stated that excellent progress has been achieved in the resolution of the above-captioned appeal. The parties were directed to file a written response to the following questions: How would closure of the Will County Unit 4 affect the permitting negotiations in this appeal and the related PCB 9-6 and PCB 13-13 appeals; and what is the estimated timeframe for resolution of this appeal. The parties were directed to file a response, either jointly or otherwise, on or before March 14, 2016.

The petitioner stated that it will file an additional waiver of the statutory decision deadline to and including August 4, 2016.

The parties or their legal representatives are directed to participate in a telephonic status conference with the hearing officer on April 7, 2016, at 10:00 a.m. The telephonic status conference must be initiated by the petitioner, but each party is nonetheless responsible for its own appearance. At the status conference, the parties must be prepared to discuss the status of the above-captioned matter and their readiness for hearing.


