NOTICE OF LIMITED WAIVER OF 120-DAY DECISION DEADLINE

NOW COMES Petitioner, J & A INVESTORS, LLC, (“Petitioner”), by and through its attorneys, HODGE DWYER & DRIVER, pursuant to 35 Ill. Admin. Code § 101.308(c)(2), hereby agrees to a limited waiver of the statutory 120-day decision deadline for final action by the Illinois Pollution Control Board (“Board”) in this proceeding until December 31, 2014. In support of this Notice, Petitioner states as follows:

1. On September 17, 2013, Petitioner filed a Petition for Review (“Petition”) of the permit determination of the “Supplemental Permit – Application of Sludge” issued to Petitioner by the Illinois Environmental Protection Agency (“Illinois EPA”) on August 14, 2013, at Petitioner’s pork harvesting facility located in Rantoul, Illinois, and operated by Rantoul Foods, LLC.
2. On October 3, 2013, the Board accepted Petitioner’s Petition for Hearing, but reserved ruling on the Motion for Stay. Board Order, *J & A Investors, LLC v. Illinois EPA*, PCB No. 14-23 (Ill.Pol.Control.Bd. Oct. 3, 2013).
3. The current statutory decision deadline for this matter is October 2, 2014.

4. Petitioner hereby voluntarily agrees to a limited waiver of the statutory 120-day decision deadline until December 31, 2014, in order to conduct settlement negotiations with Illinois EPA in this matter.

WHEREFORE, Petitioner, J & A INVESTORS, LLC, prays that the Illinois Pollution Control Board accept this limited waiver of the statutory 120-day decision deadline for final action on Petitioner's Petition for Review.
