#### POST HEARING REPLY BRIEF OF THE CITY OF CREST HILL

Based on all of the information submitted to date in this rulemaking, Crest Hill respectfully submits that it and the other Petitioners have met their burden in this matter and have sufficiently demonstrated, through competent evidence, that the requested Time-Limited Water Quality Standard (TLWQS) should be approved by the Board.

It should be noted that since the public hearing on this manner in February, the Petitioners, as a group, have worked with the IEPA and environmental groups to resolve certain issues which were raised during the hearing. Those discussions were in large part successful, and Crest Hill has no further reply on the proposed chloride variance language or the proposed permit procedure which Crest Hill believes will be submitted by IEPA.

As to the specific issue of outreach and education requirements/conditions suggested by IEPA with respect to the work groups, which was not able to be resolved, Crest Hill believes that evidence on the issue (and the position of the petitioners) was sufficiently presented during the hearing and adequately briefed in the initial post-hearing briefs, and no further reply is made at this time.

Crest Hill also adopts and incorporates the arguments and positions set forth in any Reply Briefs of similarly situated petitioners, except where they do not apply to the individual circumstances of Crest Hill.
