

HEARING OFFICER ORDER

On September 29, 2020, all parties participated in a telephonic status conference with the hearing officer. The parties appear to agree that the last testing report regarding the dust collector at issue found that the noise level was acceptable and below standards, however, the respondent is also in the process of installing additional sound barriers to close the gaps of the recently installed sound barriers. Once that is completed, the parties will again meet to discuss the noise level. If unable to reach a resolve in this matter, the respondent indicated it will file a motion for summary judgement. Overall, the parties appear to be making excellent progress in a resolution.

The parties or their legal representatives are directed to participate in a telephonic status conference with the hearing officer on November 16, 2020, at 10:30 a.m. The telephonic status conference must be initiated by the complainant, including a call-in number, but each party is nonetheless responsible for its own appearance. At the status conference, the parties must be prepared to discuss the status of the above-captioned matter and their readiness for hearing.

IT IS SO ORDERED.




