MOTION FOR HEARING OFFICER SITE VISIT

Now comes Respondent, Caseyville Transfer Station, LLC ("CTS"), by and through its attorney, Penni Livingston of the Livingston Law Firm, and hereby requests that the Hearing Officer and the Illinois Pollution Control Board Official who is responsible for observing the Hearing make a visit to the transfer station site in question, and as grounds therefore, shows to the Board as follows:

1. The proposed facility approved by the Village of Caseyville and challenged by Roxana Landfill and the Village of Fairmont City (where Waste Management's Milam facility resides), is located on the southwest corner of the intersection of Bunkum Road and the Harding

Ditch within the municipal boundaries of the Village of Caseyville (the "Site").

2. The Board has received in the Record, Respondent's Application for Siting Approval that was filed on February 10, 2014 and was complete with attachments including an aerial photograph of the proposed location of the Site in question as well as a site plan, site boundaries, building layout, and site traffic pattern map.

3. While photographs, drawings, and descriptions are helpful, a site visit would allow better understanding of the facts of the case. Seeing the surrounding area of the site and traffic patterns will provide insight into the discretion used by the Village in finding that the proposed facility meets the criteria established by the Illinois Environmental Protection Act.

4. The Illinois Pollution Control Board Official and Hearing Officer will be present in Caseyville, Illinois at Caseyville Village Hall on Tuesday October 28, 2014. The site in question is within two miles of such location and therefore making such a trip would not pose a hardship to the Official and Hearing Officer.

5. The location for the approved facility can be seen by going south on Route 157 and turning right at the light onto Bunkum Road. The property that would house the approved transfer station facility is located approximately two miles down the road on the right side.

6. Respondent Caseyville Transfer Station, LLC. and Respondent Village of Caseyville are convinced of the beneficial effect of a site visit to bring about a better understanding of the area approved for this facility as it will allow the Hearing Officer and PCB Official to obtain a tangible understanding of the distance between the approved facility and the Village of Fairmont City and Roxana Landfill.

**WHEREFORE**, the Respondent, Caseyville Transfer Station, LLC. respectfully requests that the Illinois Pollution Control Board Hearing Officer and Official observing the Hearing schedule a site visit to the property at issue prior to any final ruling in the case at hand.


