**HEARING OFFICER ORDER**


On February 27, 2014, all parties participated in a telephonic status conference with the hearing officer. The petitioner stated that it has submitted a significant modification permit application to the respondent for its review. Should the respondent approve the application, the above-captioned appeals will be dismissed. However, should the respondent deny the application, the petitioner is prepared to re-file an application based on the respondent's recommendations.

The respondent stated that it is in agreement with petitioner's intentions.

The petitioner stated that it will file an additional waiver of the statutory decision deadline to and including September 18, 2014.

The parties or their legal representatives are reminded and directed to appear at a telephonic status conference with the hearing officer on June 5, 2014, at 9:30 a.m. The telephonic status conference must be initiated by the petitioner, but each party is nonetheless responsible for its own appearance. At the conference, the parties must be prepared to discuss the status of the above-captioned matter and their readiness for hearing.


