
HEARING OFFICER ORDER

On January 19, 2017, all parties participated in a telephonic status conference with the hearing officer. Congress Development Company (CDC) stated that it has received the fourth quarter sampling results and they appear promising. The petitioner will forward the results to the respondent within the next ten days. The petitioner then is hopeful that the results will allow it to file a significant permit modification permit with the Agency and eventually result in CDC's motion to voluntarily dismiss this appeal.

The petitioner stated that it will file an additional waiver of the statutory decision deadline to and including August 17, 2017.

The parties or their legal representatives are reminded and directed to appear at a telephonic status conference with the hearing officer on May 11, 2017, at 9:30 a.m. The telephonic status conference must be initiated by the petitioner, but each party is nonetheless responsible for its own appearance. At the conference, the parties must be prepared to discuss the status of the above-captioned matter and their readiness for hearing.


