POLLUTION VARIANCE NOTICE

On July 21, 2015, the City of Cook County, Illinois, located in Cook County, filed with the Illinois Pollution Control Board a petition for variance under Section 35(a) of the Illinois Environmental Protection Act. Variances may be granted pursuant to Section 35 of the Act (4.15 ILCS 5/35) and 35 Ill. Admin. Code 104.

To assure compliance with the new chlorine standards (35 IAC 302.407(a)(2) & (3)), Country Club Hills requests a five year variance.

Any person may request a hearing by filing with the Board a written objection to the grant of the variance, together with a written request for a hearing, within twenty-one (21) days after the publication of this notice. A copy of the variance petition is available from the Clerk of the Board, Illinois Pollution Control Board, James R. Thompson Center, 100 W. Randolph Street, Suite 11-500, Chicago, Illinois 60601.

The Illinois EPA is preparing a recommendation regarding this variance petition. The Illinois EPA is to file its recommendation within forty-five (45) days after the filing of the petition. The Illinois EPA seeks the views of persons who may be
