

HEARING OFFICER ORDER

On March 26, 2015, a telephonic status conference was held. The respondent did not appear. Petitioners stated that both the respondent and the petitioners have been trying to arrange a meeting with the United States Environmental Protection Agency (USEPA) regarding the draft petitions. To date, they have been unsuccessful but will continue to seek further discussions with the USEPA. The petitioners stated that they will file an additional waiver of the statutory decision deadline to and including September 3, 2015.

The parties or their legal representatives are directed to appear at a telephonic status conference with the hearing officer on April 30, 2015, at 11:00 a.m. The telephonic status conference must be initiated by the petitioners, but each party is nonetheless responsible for its own appearance. At the conference, the parties must be prepared to discuss the status of the above-captioned matter and their readiness for hearing.


