
HEARING OFFICER ORDER

On September 12, 2013, all parties participated in a telephonic status conference with the hearing officer. The petitioners stated that they have recently forwarded additional requested information to the United States Environmental Protection Agency (USEPA) for its review. The respondent, Illinois Environmental Protection Agency (Agency), confirmed the USEPA's review of the material and stated that the USEPA has requested a meeting with the petitioner and the Agency in the near future.

The petitioner stated that it will file an additional waiver of the statutory decision deadline to and including March 20, 2014.

The parties or their legal representatives are directed to appear at a telephonic status conference with the hearing officer on November 14, 2013, at 11:00 a.m. The telephonic status conference must be initiated by the petitioners, but each party is nonetheless responsible for its own appearance. At the conference, the parties must be prepared to discuss the status of the above-captioned matter and their readiness for hearing.


