
**HEARING OFFICER ORDER**

On October 30, 2014, all parties participated in a telephonic status conference with the hearing officer. As noted in the last hearing officer order, the United States Supreme Court ruled in favor of the United States Environmental Protection Agency (USEPA) in a related case and reversed the decision of the District of Columbia Circuit Court of Appeals. The petitioner stated that the stay has now been lifted and that the USEPA has opined that Phase I will commence on January 1, 2015. The issues in the related case involve the Cross-State Air Pollution Rule that is relevant to this variance petition.

Petitioner further stated that it intends to file an amended variance petition with the Board, primarily changing the various dates found in the petition that was filed on June 8, 2012.

The parties or their legal representatives are directed to participate in a telephonic status conference with the hearing officer on December 11, 2014, at 10:30 a.m. The telephonic conference must be initiated by the petitioner, but each party is nonetheless responsible for its own appearance. At the conference, the parties must be prepared to discuss the status of the above-captioned matter and their readiness for hearing.


