ORIGINAL

On August 25, 2016, all parties participated in a telephonic status conference with the hearing officer. The complainant stated that the state implementation plan, including the emission limits adopted in R15-21, is still under review by the United States Environmental Protection Agency. The complainant also stated that settlement discussions were held with the respondent since the last status conference. To that end, it was agreed that complainant's response to respondent's affirmative defenses are now due on or before March 2, 2017.

The parties are encouraged to consent to receive e-mail service of my orders. Consent may be e-mailed and need only include a name, e-mail address and reference to this docket number.

The parties or their legal representatives are directed to participate in a telephonic status conference with the hearing officer on February 16, 2017, at 11:30 a.m. The telephonic conference must be initiated by the complainant, but each party is nonetheless responsible for its own appearance. At the conference, the parties must be prepared to discuss the status of the above-captioned matter.


