

**HEARING OFFICER ORDER**

On June 3, 2021, all parties participated in a telephonic status conference with the hearing officer. The respondent reported that their noise consultant is still attempting to alleviate some of the base sound around the site. Nonetheless, respondent stated that it intends to file a motion for summary judgment within the next 30-45 days. The complainant stated that he does not agree that the decibel level/measurements fall below the requirements. Mr. Kruk further maintains that additional measurements from different locations need to be completed.

The parties or their legal representatives are directed to participate in a telephonic status conference with the hearing officer on August 9, 2021, at 10:30 a.m. The telephonic status conference must be initiated by the complainant, but each party is nonetheless responsible for its own appearance. At the status conference, the parties must be prepared to discuss the status of the above-captioned matter and their readiness for hearing. The respondent will provide the call-in number.
