

HEARING OFFICER ORDER

On February 18, 2016, all parties participated in a telephonic status conference with the hearing officer. The complainant stated that it is still considering filing a complaint in circuit court and is still in discussions with respondent City of Morris and the Illinois Environmental Protection Agency in an attempt to resolve the alleged violations. The complainant again opines that it will have a decision by the next status conference on whether to file a motion to dismiss this matter and proceed in circuit court or move forward with this matter before the Board.

The parties or their legal representatives are directed to appear at a telephonic status conference with the hearing officer on April 28, 2016, at 11:30 a.m. The telephonic status conference must be initiated by the complainant, but each party is nonetheless responsible for its own appearance. At the conference, the parties must be prepared to discuss the status of the above-captioned matter and their readiness for hearing.

IT IS SO ORDERED.




