
HEARING OFFICER ORDER

On October 22, 2014, all parties participated in a telephonic status conference with the hearing officer. The petitioner stated that it has recently forwarded a draft consent decree to the respondent for its review. The consent decree involves a related circuit court case. If a consent decree is filed in the circuit court, this appeal before the Board will be moot.

The petitioner stated that it will file an additional waiver of the statutory decision deadline to and including March 19, 2015. It was agreed that the record in the above-captioned matter is now due to be filed on or before January 15, 2015.

The parties or their legal representatives are directed to appear at a telephonic status conference with the hearing officer on December 18, 2014, at 10:00 a.m. The telephonic status conference must be initiated by the petitioner, but each party is nonetheless responsible for its own appearance. At the status conference, the parties must be prepared to discuss the status of the above-captioned matter and their readiness for hearing.

IT IS SO ORDERED.




