

**HEARING OFFICER ORDER**

On October 17, 2013, all parties participated in a telephonic status conference with the hearing officer. Respondent's filing date may or may not need to be addressed at the next status conference.

The parties or their legal representatives are directed to participate in a telephonic status conference with the hearing officer on November 7, 2013, at 10:30 a.m. The telephonic conference must be initiated by the complainant, but each party is nonetheless responsible for its own appearance. At the conference, the parties must be prepared to discuss the status of the above-captioned matter and their readiness for hearing.

IT IS SO ORDERED.




