
HEARING OFFICER ORDER

On March 24, 2016, all parties participated in a telephonic status conference with the hearing officer. The respondent stated that since the last status conference, discussions between it and the United States Environmental Protection Agency (USEPA) has taken place, however, further discussions are needed. It is noted that the parties have reached an agreement on the proposed NPDES permit and that it has been forwarded to the USEPA for its review. The parties remain cautiously optimistic that the USEPA will approve the permit.

The petitioners stated that they will file additional and respective waivers to at least August 4, 2016.

The parties or their legal representatives are directed to appear at a telephonic status conference with the hearing officer on April 27, 2016, at 9:30 a.m. The telephonic status conference must be initiated by the petitioners, but each party is nonetheless responsible for its own appearance. At the conference, the parties must be prepared to discuss the status of the above-captioned matter and their readiness for hearing.
