MOTION FOR EXTENSION OF TIME TO FILE RECOMMENATION

NOW COMES the Illinois Environmental Protection Agency ("Illinois EPA") by one of its attorneys, Deborah J. Williams, and moves the Hearing Officer, pursuant to 35 Ill. Adm. Code 101.502 and 104.416(a), to grant it an extension of time to file its response to the Petition of Noveon, Inc. ("Noveon" or "Petitioner") for an Adjusted Standard from 35 Ill. Adm. Code 304.122, due on May 15, 2003, for an additional thirty (30) days. In support of its request, the Illinois EPA states as follows:

- On May 22, 2002, Noveon filed a Petition for an Adjusted Standard with Illinois Pollution Control Board ("Board"). The Petition requests relief from 35 Ill. Adm. Code 304.122 as these regulations apply to the discharge of ammonia nitrogen from Noveon's Henry, Marshall County, Illinois facility.
- Pursuant to Section 28.1(d) of the Environmental Protection Act, Petitioner filed a Certificate of Publication with the Board on June 11, 2002 stating that notice of the adjusted standard petition was timely published on May 29, 2002. 415 ILCS 5/28.1(d). On June 20, 2003, the Board accepted the Petition for hearing.
- 3. The Illinois EPA is required to respond to a Petition for Adjusted Standard within forty-five (45) days of filing pursuant to 35 Ill. Adm. Code 104.416. Hearing Officer Orders dated January 22, 2003 and March 20, 2003 extended the deadline

for submittal of the Illinois EPA's Recommendation in this matter until May 15, 2003.

- 5. On April 21, 2003, the Illinois EPA filed a Motion for Withdrawal and Substitution of Counsel and Deborah J. Williams filed an appearance in this matter. The time provided by the Hearing Officer Orders has been inadequate for the new Illinois EPA attorney assigned to this matter to complete review of the extensive background materials in the matter and prepare the Illinois EPA's Recommendation. In addition, a Freedom of Information Act review of the Illinois EPA files in this matter will cause the necessary documents to be unavailable for the Agency attorney's use for several days.
- 6. In a telephone conversation on May 6, 2003, counsel for the Petitioner stated that
 Petitioner does not object to the Illinois EPA's request for additional time to respond.
- 7. Petitioner will suffer no prejudice should the Illinois EPA be granted an extension of its time to respond to its Adjusted Standard petition.

WHEREFORE, the Illinois EPA respectfully requests that the Hearing Officer grant it an extension of time in which to respond to the Petition of Noveon, Inc. for Adjusted Standard for an additional thirty (30) days.
