
**HEARING OFFICER ORDER**

On August 19, 2021, all parties participated in a telephonic status conference with the hearing officer. The petitioner stated that it will file an additional waiver of the statutory decision deadline to and including March 31, 2022.

IT IS SO ORDERED.




