**HEARING OFFICER ORDER**


On March 24, 2014, all parties participated in a telephonic status conference with the hearing officer. On March 20, 2014, the petitioner filed a motion for expedited review of hearing officer order issued March 20, 2014. It was agreed that respondents must file their respective responses on or before March 28, 2014. The petitioner's reply must be filed on or before March 31, 2014. The mailbox rule does not apply and all electronic or approved telefax filings must be received by the Clerk's Office no later than 4:30 p.m. of the due date.

It was also agreed that the discovery schedule outlined in the February 4, 2014, hearing officer order be revised to the extent that all responses to written discovery must be provided on or before March 31, 2014. All other dates remain the same.

Finally, the Village of Round Lake Park (Village) filed a "Motion to Withdraw its Motion to Make Specific, Reply and Board Appeal" on March 24, 2014. These relate to the Village's filings on March 17, 2014 and March 18, 2014. The Village's motion is granted.

The parties or their legal representatives are directed to appear at a telephonic status conference with the hearing officer on April 3, 2014, at 1:30 p.m. The telephonic status conference must be initiated by the petitioner, but each party is nonetheless responsible for its own appearance. At the conference, the parties must be prepared to discuss the status of the above-captioned matter and their readiness for hearing.


