
**HEARING OFFICER ORDER**

On February 27, 2014, all parties participated in a telephonic status conference with the hearing officer. The petitioner stated that discussions are ongoing and that the parties have made progress regarding language in the consent decree that is anticipated to be filed in state court on related cases. The petitioner states that once the consent decree is filed, the above-captioned appeal before the Board will be rendered moot.

Finally, it was agreed that respondent must file the record on or before March 31, 2014.

The parties or their legal representatives are directed to appear at a telephonic status conference with the hearing officer on March 17, 2014, at 9:15 a.m. The telephonic status conference must be initiated by the petitioner, but each party is nonetheless responsible for its own appearance. At the status conference, the parties must be prepared to discuss the status of the above-captioned matter and their readiness for hearing.

IT IS SO ORDERED.




