
HEARING OFFICER ORDER

On December 4, 2014, all parties participated in a telephonic status conference with the hearing officer. It was noted that on December 3, 2014, respondent filed a motion to consolidate the related complaint docketed as PCB 14-81 with the above-captioned matter. The complainant stated that it has yet to decide whether to file a response.

The parties further stated that discovery is continuing in the related case in circuit court, including exchanging documents, depositions and disclosure of witnesses in the upcoming months. The proceedings in circuit court are related to this matter before the Board.

The parties or their legal representatives are directed to participate in a telephonic status conference with the hearing officer on February 5, 2015, at 9:00 a.m. The telephonic status conference must be initiated by the complainant, but each party is nonetheless responsible for their own appearance. At the status conference, the parties must be prepared to discuss the status of the above-captioned matter and their readiness for hearing.


