
HEARING OFFICER ORDER

On November 26, 2013, all parties participated in a telephonic status conference with the hearing officer. The petitioners stated that the meeting held last week with the United States Environmental Protection Agency (USEPA) and the Illinois Environmental Protection Agency was productive and remains hopeful these above-captioned variances are closer to a resolve. The petitioners stated that they will forward additional information as a result of the meetings to the USEPA for its review.

The petitioners stated that they will file additional waivers of the statutory decision deadline to and including May 15, 2014.

The parties or their legal representatives are directed to appear at a telephonic status conference with the hearing officer on January 30, 2014, at 11:00 a.m. The telephonic status conference must be initiated by the petitioners, but each party is nonetheless responsible for its own appearance. At the conference, the parties must be prepared to discuss the status of the above-captioned matter and their readiness for hearing.


