
HEARING OFFICER ORDER

On June 4, 2015, all parties participated in a telephonic status conference with the hearing officer. The petitioners stated that they have a meeting scheduled for the week of June 8, 2015, with an Illinois Environmental Protection Agency permit technician. The parties are optimistic that a permit will eventually be issued.

The petitioners stated that they will file an additional waiver of the statutory decision deadline to and including October 15, 2015.

The parties or their legal representatives are directed to appear at a telephonic status conference with the hearing officer on July 9, at 10:30 a.m. The telephonic status conference must be initiated by the petitioners, but each party is nonetheless responsible for its own appearance. At the conference, the parties must be prepared to discuss the status of the above-captioned matter and their readiness for hearing.


