HEARING OFFICER ORDER

On December 7, 2015, the parties were scheduled to participate in a telephone status call. Neither party appeared, but the petitioner's attorney gave prior notice of his inability to attend. As last reported, the substantive issues of this appeal were resolved in 2009, and petitioner continues to operate in compliance with federal and state regulations. There is no indication that respondent is working on the permit, and petitioner is content to wait.

On December 17, 2015, the Board directed respondent to provide an updated status of this permit appeal within 30 days, including an estimated time for issuance of a permit. Petitioner was also invited to submit a status report.

The parties are directed to participate in a telephone status conference with the hearing officer at 10:00 a.m. on January 26, 2016. Petitioner shall initiate the call or circulate a conference call-in number.

Petitioner filed an open waiver of the statutory decision deadline in this matter.
