**HEARING OFFICER ORDER**


On April 5, 2016, all parties participated in a telephonic status conference with the hearing officer. Complainant's counsel stated that he will not file an amended reply to the affirmative defenses but instead filed a motion to strike affirmative defenses. Respondent Highland Hills Sanitary District (Highland Hills) stated that it intends to file a response.

Highland Hills also stated that it is having difficulty receiving possible inspection dates from complainant. Counsel for complainant stated that his client Susan Bruce is having back issues and may need surgery. Counsel stated that he has tried to contact Susan Bruce seven times in the last seven days but to no avail. Counsel will continue his efforts.

The parties' again requested that all discovery dates, including request to admit responses, be held in abeyance until at least the next scheduled telephonic status conference or when the Board rules on the motion to strike. Discovery dates will be revisited at the next status conference. The parties request was granted.

The parties or their legal representatives are directed to participate in a telephonic status conference with the hearing officer on April 14, 2016, at 10:00 a.m. The telephonic status conference must be initiated by the complainant, but each party is nonetheless responsible for its own appearance. At the conference, the parties must be prepared to discuss the status of the above-captioned matter and their readiness for hearing


