On June 16, 2016, a telephonic status conference was held. The complainant did not appear. Complainant, however, did communicate his apologies to all parties *via* e-mail after the conference had been concluded.

After reviewing respondent's written objection to complainant's motion for an extension of time to file her response to respondent's requests for admission, complainant's motion was granted to the extent that her response is due to be filed on or before June 17, 2016. The complainant is also reminded again to provide the documents promised to the respondent numerous times.

The parties or their legal representatives are directed to participate in a telephonic status conference with the hearing officer on June 29, 2016, at 1:00 p.m. The telephonic status conference must be initiated by the complainant, but each party is nonetheless responsible for its own appearance. At the conference, the parties must be prepared to discuss the status of the above-captioned matter and their readiness for hearing.
