### RESPONDENT ROUND LAKE PARK VILLAGE BOARD'S MOTION FOR LEAVE TO FILE AN ELECTRONIC COPY OF THE RECORD REQUIRED BY 35 ILL. ADM. CODE 107.304 IN PLACE OF PAPER COPIES AND/OR FOR CLARIFICATION OF THE REQUIREMENT TO FILE "SEVEN COPIES OF THE TRANSCRIPT AND ONE ORIGINAL AND 9 COPIES OF ALL OTHER DOCUMENTS"

Respondent, Round Lake Park Village Board, moves for leave to file an electronic copy of the record required by 35 Ill. Adm. Code 107.304 in place of paper copies and/or for clarification of the requirement of 35 Ill. Adm. Code 107.304 to file "(s)even copies of the transcript and one original and 9 copies of all other documents," and in support thereof, states as follows:

## I. Request for leave to file electronic copy of record

1. 35 Ill. Adm. Code Section 107.304 sets for the requirements for the contents and manner in which the record of all information and evidence presented to the Village of Round Lake Park, as the local siting authority, must be filed with the Illinois Pollution Control Board (hereinafter "Board").

2. 35 Ill. Adm. Code Section 107.304(c) requires that "(s)even copies of the transcript and one original and 9 copies of all other documents" must be filed with the Board.

3. 35 Ill. Adm. Code Section 107.304 does not require that such copies of the record

be filed on paper, which leaves the possibility of filing an electronic copy.

4. Filing copies of an electronic copy of the record is a far more environmentally

sound and economical alternative to filing the record on paper.

5. The Board and all parties involved would benefit from the Respondent Village

Board of Round Lake Park filing an electronic copy of the record.

# II. Request for clarification of the requirement of 35 Ill. Adm. Code 107.304 to file "(s)even copies of the transcript and one original and 9 copies of all other documents."

1. 35 Ill. Adm. Code Section 107.304(c) provides:

"c) Seven copies of the transcript and one original and 9 copies of all other documents in the record must be filed with the Board."

2. Respondent Village Board of Round Lake Park requests clarification as to whether the Board wishes either "seven copies of the transcript and one original, and 9 copies of all other documents", or "seven copies of the transcript, and one original and 9 copies of all other documents."

WHEREFORE, Respondent, Round Lake Park Village Board, respectfully requests that the Pollution Control Board enter an order allowing Respondent Round Lake Park Village Board to file an electronic copy of the record required by 35 Ill. Adm. Code 107.304 in place of paper copies and to clarify the requirement of 35 Ill. Adm. Code 107.304 to file "(s)even copies of the transcript and one original and 9 copies of all other documents," and for such further and other relief as this Board deems just and proper.
