2 this Illinois Pollution Control Board Hearing.

3 My name is Vanessa Horton, and I'm the  
4 Hearing Officer for this Rulemaking proceeding  
5 entitled In the Matter of Amendments to 35 Illinois  
6 Administrative Code Subtitle F: Public Water  
7 Supply.

8 The Board docket number for this  
9 Rulemaking is R18-26.

10 Also present today from the Board are  
11 Chair of the Board, Barbara Flynn Currie, Board  
12 Member Jennifer Van Wie, environmental scientist,  
13 Essence Brown, staff attorney Daniel Pauley, and  
14 attorney advisor Mark Kaminsky.

15 This hearing is governed by the Board's

9 it, COOL.

10           Notice for this hearing was posted on  
11 September 20, 2021 in the Chicago Sun Times and  
12 September 21, 2021 in the Springfield Journal  
13 Register.

14           On September 17, 2021 the Hearing  
15 Officer directed that any pre-trial testimony was  
16 to have been filed with the Board by October 5th,  
17 2021. We did not receive any pre-trial testimony  
18 by that date.

20 today who did not pre-file testimony for this  
21 hearing that would like to offer testimony?

23           Is there anyone present here today who  
24 wishes to offer public comments at this hearing?

11 service list.
