JURISDICTION

This Administrative Citation is issued pursuant to the authority vested in the Illinois Environmental Protection Agency by sections 4(e) and 31.1 of the Illinois Environmental Protection Act ("Act"), 415 ILCS 5/4(e), 5/31.1, and delegated to Vermilion County pursuant to section 4(r) of the Act, 415 ILCS 5/4(r).

FACTS

1. That Respondent, Elvis Ford, was the owner and occupier of a property located at 669 Don Avenue, Danville Township, within the County of Vermilion, State of Illinois, known as tract number DOR 864 D (hereinafter referred to as the "subject property") at all times relevant to this Administrative Citation.

2. That the subject property is not licensed as, nor does it fulfill the requirements of a sanitary landfill.

3. That on November 18, 1996, Douglas Toole of the Vermilion County Health Department inspected the subject property. A copy of the inspection report is attached hereto and made a part hereof.

VIOLATIONS

On the basis of the direct observation of Douglas Toole, the County of Vermilion has determined that on November 18, 1996, Respondent allowed open dumping on the subject property in violation of section 21(a) of the Act, 415 ILCS 5/21(a), in a manner which resulted in litter at the site, as prohibited by section 21(p)(1) of the Act, 415 ILCS 5/21(p)(1). Respondent also allow 2d open burning of the litter on the subject property in violation of section 21(a) of the Act, 415 ILCS 5/21(a), in a manner as prohibited by section 21(p)(3) of the Act, 415 ILCS 5/21(p)(3).

CIVIL PENALTY

Pursuant to section 42(b)(4) of the Act, 415 ILCS 5/42(b)(4), Respondent herein is subject to a civil penalty for each of the above mentioned violations in the sum of Five Hundred Dollars (\$500.00), for a total civil penalty of One Thousand Dollars (\$1,000.00). Additionally, should Respondent elect to petition the Illinois Pollution Control Board under the review process described herein below, and if there is a finding of the violation alleged herein after an adjudicatory hearing, Respondent shall be assessed the associated hearing costs incurred by the Illinois Pollution Control Board, in addition to the One Thousand Dollar (\$1,000.00) statutory penalty for the violation.

PROCEDURE FOR CONTESTING THIS ADMINISTRATIVE CITATION

You have the right to contest this Administrative Citation under section 31.1(d) of the Act, 415 ILCS 5/31.1(d). If you elect to contest this Administrative Citation, you must file a Petition for Review with the Clerk of the Illinois Pollution Control Board at the State of Illinois Center, 100 West Randolph St., Suite 11-500, Chicago, Illinois 60601. A copy of the Petition for Review should be filed with the Vermilion County State's Attorney's Office, 7 N. Vermilion St., Danville, Illinois 61832. The Petition for Review <u>must</u> be filed with the Illinois Pollution Control Board within thirty-five (35) days of the date of service of this Administrative Citation, or a default judgment will be issued.

If you acknowledge the violation cited herein, the civil penalty specified above shall be due and payable no later than January 23, 1997. If you do not petition the Illinois Pollution Control Board for review of this Administrative Citation within thirtyfive (35) days of service hereof, or if you elect to contest this Administrative Citation, any judgment rendered against you shall specify the due date of the statutory civil penalty and any costs assessed against you.

When payment is made, your check should be made payable to the County of Vermilion, Illinois, and mailed to the Vermilion County Health Department, 200 South College Street, Danville, Illinois 61832.

If any civil penalty, by reason of acknowledgment, default or finding after adjudicatory hearing, is not paid when due, the Vermilion County State's Attorney may initiate proceedings in the Circuit Court to collect said civil penalty. In addition to the previously assessed civil penalty and any hearing costs of the Illinois Pollution Control Board, the State's Attorney's Office will seek to recover its costs of litigation.

OPEN DUMP INSPECTION NARRATIVE

This unpermitted open dump was reinspected on November 18, 1996, by Douglas Toole of the Vermilion County Health Department. The weather was cloudy, damp and about 40 degrees Fahrenheit. Eight photos were taken of the site.

The site is located in Vermilion County, southeast of Danville, Illinois. Specifically, the site is located at the east end of Don Avenue in rural Danville.

INSPECTORS FINDINGS

I arrived on the site at about 10:20 a.m. on November 18, 1996. No one else was present during my reinspection. In general, there appeared to be more refuse on the site than there was on the September 25, 1996 reinspection.

There were more wooden power poles on the southwest part of the site (photos 1, 2). Next to the power poles was a small waste pile containing tires, boards, roofing shingles, insulation, an appliance and other refuse (photo 3). Next to the northern mobile home were two small piles containing tires, scrap metal, boards and other refuse (photo 4).

The main waste pile still contained mattress springs, a toilet seat, boards, scrap metal and other refuse -- some of which appeared to be partially burned (photos 5-8). It appeared that fresh, unburned refuse such as carpeting, boards and scrap metal had been recently added to the west side of the main waste pile (photo 5). I left the site at about 10:25 a.m.

On the Inspection Report Checklist for this reinspection, I estimated that there were 60 cubic yards of waste on the site. No measurements were performed to arrive at that estimation, only my observations at the time. The actual amount of waste on the site may vary significantly from that estimation.

SUMMARY OF APPARENT VIOLATIONS

Section 21 (p)(3) of the Act: No person shall...cause or allow the open dumping of any waste in a manner which results in...open burning. Evidence of open burning was observed on the site.

Section 55 (a)(1) of the Act: No person shall...cause or allow the open dumping of any used or waste tire. Waste tires were observed on the site.
